1. The annual Enrollment Contract is valid September 1 through August 31. Annual Tuition is re-evaluated with each school year. Annual Tuition is divided into equal monthly installments for your convenience.
2. A non-refundable Application Fee of \$50 is due at the time of application for each child.

3. A one-time Commitment Deposit of \$450 per Children's House applicant, or \$600 per Toddler Community applicant is due with a signed Enrollment Contract for each child upon acceptance. The Commitment Deposit is credited to the final tuition payment as your child completes the Kindergarten year at CHMS.
4. A non-refundable Annual Enrollment Deposit of \$300 is collected at the time of re-enrollment each year, and is credited toward tuition at \$25 each month over the 12-month contract.
5. A 5% tuition discount applies for the oldest enrolled sibling.
6. The annual Enrollment Contract is valid September 1 through August 31. Student(s) withdrawn for any reason will result in a forfeiture of the Commitment Deposit. CHMS requires 60-days notice to cancel the annual Enrollment Contract. Families will be obligated to pay the pro-rated tuition for 60 days following notification of intent to withdraw.
7. Tuition Aid is available to qualifying families. Current families will receive priority consideration. Applications for Tuition Aid are processed by the School and Student Services (a third party division of the National Association of Independent Schools) and reviewed on a case-by-case basis, using need-based qualifiers for determining eligibility by the Financial Aid Committee. Tuition Aid awards are available on a limited basis, and re-evaluated during the re-enrollment period each year.
8. Extended Care Hours may be available on a per diem basis at \$10 per hour. You are asked to seek approval from Administration at least 24 hours in advance. Extended Care Hours are not guaranteed, and approval is contingent on the number of children and staff already scheduled.
9. For a Late Pick Up, Parent/Guardian agrees to pay a charge of \$5.00 after the first five minutes past the contracted program time and \$1.00 per additional minute late.
10. Tuition payments received after the 5th of the month, will be assessed a \$25.00 late fee.
11. An optional Hot Lunch, offered two days a week on Mondays and Fridays, is available to all Children's House students on a monthly contract. An additional monthly fee of \$40 is applied.
